### The U.S. Public School System Needs Reform---But What Kind of Reform?

### CHARTER SCHOOLS

Since "No Child Left Behind" (NCLB) was passed by Congress in 2001, charter schools have been sprouting up all over. The idea behind charter schools is a good one. The charter school gets public funding, and the people who run the charter school can use the public funding any way they choose, they can pay teachers what they want, hire and fire at their discretion without unions interfering, and teach whatever curriculum they want. Here's the problem: Charter schools are not being run by altruistic, educational visionaries, they are being run by hedge fund managers. It's big business. If they can increase their bottom line, they can invest in more charter schools, make a bigger profit, and then create a documentary like "Waiting for Superman," that extols the virtues of "designer" charter schools that have been heavily financed by the hedge fund managers to look good. Most of the charter schools don't make it past five years. The turnover is high because the staff isn't paid enough, and in many cases, they are not as well organized as most public schools. Charter schools are being pushed by the League of Education Voters (LEV), Eli Broad, (The Broad Foundation), Bill Gates, Wendy Kopp (Teach for America), and of course Arne Duncan, our Secretary of Education—who by the way, never taught school. As time goes on, the evidence is showing that the luster is starting to wear off the popularity of charter schools. ### **TEACH FOR AMERICA**

Wendy Kopp started Teach For America (TFA) in 1990. After an initial grant from Exxon Mobil, TFA started recruiting new Ivy League college graduates to "teach" in rural and urban schools with teaching shortages. These graduates were not teaching majors, but mostly liberal arts majors that fit the profile for what TFA was looking for: young, eager and positive individuals with limitless energy. The problem is, they had no training to be teachers. Today, TFA has an operating budget of over \$100 million dollars. There is also an army of corporate missionaries ready and willing to support the cause. We seem to see the same names over and over again, Eli Broad, Bill Gates, Richard Barth (Kipp Charter Schools), The Walton Family, and Goldman Sachs, to name a few corporate missionaries who have given millions to TFA and charter schools.

Secretary of Education Arne Duncan's Race to the Top initiative approaches student underachievement with the same methods as George W Bush's No Child Left Behind but in a more creatively financed. high-stakes game for school districts. The \$4.5 billion program entices cash-strapped localities to compete for federal monies by placing test scores, teachers, principals and superintendents in the crosshairs, tying student achievement to cash.

Steve Barth with KIPP, and my personal favorite, Ben Austin with the Parent Trigger, is now sponsoring an evening with Wendy Kopp, the founder of Teach for America, Inc. (TFA), to extol the virtues of her organization.

Sue and I have written on this blog about Teach for America, Inc. and how recruits recently graduated from college are used to populate charter schools with cheap labor after five weeks of training to work specifically in lowpoverty schools for two years before continuing on in their chosen professions which is usually not in the field of education. The privatizers call this the panacea that will cure all that ails the educational system in our country, that and charter schools.

### Free faxes!

Email, for obvious reasons, is restricted to constituents. Phones and faxes are not. For critical issues, consider adding faxes to your activist arsenal. Sometimes staff will ask your address when you call. If you are not in the district of the representative you call, explain that you are calling about his/her role in the SuperCongress, not as a member of the particular district.

A note on free faxes: they must be from a valid email address. When you send a fax, they send it first to your email address and give you a link to click on. Only clicking the link you got by email will send the fax. **Limit 2 per day, no more than 3 pages.** For \$10/month you can send more faxes and more pages. If you want to ramp up your activities as an online activist, and can afford it, this would be a good investment.

### Talking points

Do NOT raise the Medicare eligibility age from 65 to 67. This would be a de facto death sentence for all too many people, and it won't even save money. That's because people will postpone medical care, and when they finally become eligible, they will be sicker and more expensive to treat.

Do NOT raise the Social Security retirement age to 69 or 70, or the age at which one can collect benefits from 62 to 64. All too many people over age 55 have been forced from the labor market involuntarily, and are spending their retirement savings on survival in the hope of hanging on until they reach 62.

Do NOT cut Medicaid. This will require the states to cut people from the program and reduce provider payment rates. 70% of people in nursing homes are now on Medicaid. What will happen to them if they can no longer get it?

Do NOT make existing inadequate Social Security cost of living increases even more inadequate by using the chained CPI calculation method. This works like compound interest, only in reverse. Instead of getting richer over time, you get poorer.

Currently, those earning more than \$106,500/year pay no Social Security taxes (FICA) on income above that level. DO raise or eliminate the FICA cap. This will make Social Security solvent for 75 years.

DO eliminate the Bush tax cuts, a primary cause of the deficit. Raise taxes further on the wealthiest. Eliminate the capital gains tax break.

DO enact a policy for Medicare Part D which allows the government to negotiate drug prices.

### Keep Valley Medical Center Public

Elect Dr. Mary Alice Heuschel as Commissioner of Public Hospital District #1

### What is a Public Hospital District?

Public hospital districts are governmental entities established by Washington State statute. The legislature granted local communities the authority to create hospital districts in 1945. Today, nearly one-half of Washington's 90 hospitals are part of public hospital districts. Valley Medical Center—Public Hospital District No. 1—is the oldest and largest in Washington, encompassing the cities of Kent, Renton, two-thirds of Tukwila, and portions of Auburn, Black Diamond, Covington, Federal Way, Maple Valley, Newcastle and Seattle. The oldest and largest of the 56 hospital districts in the state of Washington, it operates Valley Medical Center, serving greater South King County.

Public hospital districts fulfill a vital role in the state's healthcare system. Without them many people would be unable to receive healthcare in their own communities. Hospital districts are authorized not only to operate a hospital, but to deliver any service to help people stay healthy—physically, socially, and mentally. Because they're owned and governed by local citizens, hospital districts tailor their services to meet the unique needs of their individual communities. It is this community-based mission that defines and distinguishes hospital districts from other healthcare entities.

South King County has some of the most medically vulnerable people in the county, and healthcare already is a luxury for many of them. They need responsive leadership taking their best interests to heart, even if their decisions aren't the most profitable ones. 40% of emergency room patients at Valley are not insured.

### Dr. Heuschel stands for

- Keeping Valley Medical public and <u>open to all</u>. Her opponents are comfortable with or explicit advocates of selling off this critical public asset in bits and pieces.
- Effective development of the recent strategic alliance with UW Medicine, which will provide greater access to many types of specialty care. Her opponents are lukewarm about or actively opposed to this alliance.
- Responsible, transparent accounting of the Valley Medical Center budget, including the South King County taxpayer dollars which provide 2% of that budget.

This election is not about who has the cutest kids, or who has put in the most hours of public service, though Dr. Heuschel's family is lovely and she has an extensive history of exemplary public involvement, as indicated by her recent naming by public school superintendents as the 2011 Washington State Superintendent of the Year.

# This election is about keeping a critically important public asset public, and strengthening and improving it.

The candidate who has pledged to keep the hospital public is behind the candidate who wants to sell off the assets of Public hospital district #1. In order to win in the general election in a low-turnout odd-numbered year, Dr. Heuschel needs financial support and volunteers to doorbell and phone bank.
