# Social Security Speaker Training Sep 20th 6:30—8:30 pm

Social Security has become a political issue. There are proposals to modify the program. Some proposals would extend the life of the current program. Some would reduce access to Social Security benefits.

Social Security Works WA, a coalition committed to protecting and strengthening Social Security is creating a Speakers Bureau of people who can speak publically on how we can preserve and improve Social Security. They will train interested individuals to speak to groups (from small to large) about Social Security's history, status, and future security. #### Obama vs Romney

Here is a summary of my research on Medicare and the Budget, with a summary of comparative policies drawn from my research.

#### Obama/Biden Medicare Cuts

#### Romney/Ryan's Medicare Cuts

Reduces reimbursements paid to Medicare Advantage plans to minimize subsidies to insurance companies, private providers, & Big Pharma

Closes "donut hole" in Prescription Drug Coverage & allows Medicare to negotiate drug costs for bulk discounts (like the VA)

Rewards doctors and hospitals for efficiencies that result in better patient outcomes costing tity over quality; ie, excessive and duplicate less money

Reduces critical care costs by increasing preventive care coverage; i.e., no co-pays for annual physical exams, preventive care & tests; resulting in improved health & less costly critical care

Redirects savings into increased Medicare and Medicaid coverages for annual physical exams and other preventive care

Savings (cuts) = \$716 billion reinvested in Medicare, Medicaid, and Obamacare: resulting in healthier Americans

Allows insurance companies, private providers, and Big Pharma to continue collecting excessive reimbursements regardless of care provided

Leaves "donut hole" in place and continues to require Medicare to pay full retail prices for all pharmaceuticals

Leaves in place a system that rewards quantests and procedures

Leaves in place ever-increasing co-pays for annual physical exams, preventive care and tests, necessitating more critical care for those with less financial ability

Provides an annual voucher of \$8,000 to all recipients to use for medical care or to purchase private insurance. Costs over the voucher amount are out-of-pocket.

Savings (cuts) = \$716 billion re-directed to tax cuts, primarily for the top 2% of Americans; resulting in a wealthier top 2%

#### Obama/Biden Budget

#### Romney/Ryan Budget

Decreases defense spending by eliminating unwanted and unneeded equipment. Caps military spending.

Increases defense spending to support "American Exceptionalism" around the world. Removes cap on military spending.

Increases top income tax rate (over \$250,000/yr) by 3.6%, Increases capital gains tax by 5%, taxes dividend income as ordinary (wage) income

Reduces top income tax rates by 16%, lowers tax rate on capital gains and dividend income to zero, repeals the Alternative Minimum Tax

Eliminates perpetual tax breaks and loopholes to Big Oil, Big Pharma, and other corporate entities

Maintains perpetual corporate tax breaks and loopholes for Big Oil, Big Pharma, and other corporate "persons"

Limits home mortgage interest deduction to mortgage balances \$500,000. or less

Eliminates individual tax breaks for employer-provided health coverage, home mortgage interest, 401K contributions, charitable giving, and property taxes

Fully funds Medicaid support to the States

De-funds Medicaid; places full burden on

the States

Balanced budget in 2022

# **State Measures**

<b>Initiative 1185 -2/3 Majority to raise taxes</b> —This measure would restate existing statutory requirements that legislative actions raising taxes must be approved by two-thirds legislative majorities or receive voter approval, and that new or increased fees require majority legislative approval. Should this measure be enacted into law? [] Yes [] No
<b>Initiative 1240</b> – <b>Charter Schools-</b> This measure would authorize up to forty publicly-funded charter schools open to all students, operated through approved, nonreligious, nonprofit organizations, with government oversight; and modify certain laws applicable to them as public schools.

Referendum Measure 74- Marriage Equality The legislature passed Engrossed Substitute Senate Bill 6239 concerning marriage for same-sex couples, modified domestic-partnership law, and religious freedom, and voters have filed a sufficient referendum petition on this bill.  This bill would allow same-sex couples to marry, preserve domestic partnerships only for
seniors, and preserve the right of clergy or religious organizations to refuse to perform, recognize, or accommodate any marriage ceremony.  Should this bill be: [] Approved [] Rejected
Initiative 502—Marijuana Legalization— This measure would license and regulate marijuana production, distribution, and possession for persons over twenty-one; remove state-law criminal and civil penalties for activities that it authorizes; tax marijuana sales; and earmark marijuana-related revenues.

Senate Joint Resolution 8221—Washington Debt Limit
The Legislature has proposed a constitutional amendment on implementing the Commission on State Debt recommendations regarding Washington's debt limit.
This amendment would, starting July 1, 2014, phase-down the debt limit percentage in three steps from nine to eight percent and modify the calculation date, calculation period, and the term general state revenues.

Senate Joint Resolution 8223 - State University investment rules The Legislature has proposed a constitutional amendment on investments by the University of Washington and Washington State University.
This amendment would create an exception to constitutional restrictions on investing public funds by allowing these universities to invest specified public funds as authorized by the legislature, including in private companies or stock.
